- 2. For trading at the Integrated Trading Area Baumgarten "ITAB" (as a virtual point) and the use of back-up/back-down services, also signing of Appendix F is required.
- 3. For using Wheeling Services in accordance with Appendix A2 the separate usage of Appendix A2 forms is required. Each form has to be duly signed.
- 4. This Agreement shall take effect on the date of signature by both Parties.
- 5. This Agreement shall be signed in two originals; one for each Party.
